November 26, 2024, Victoria BC Canada

Today with the help of another approved buoyancy certifier (Bill Marshall) we performed a comparison check as below.

Boat: 2017 Charger 2.4mR (WS #979) (NOD #260)

Race Weight = 254kg

Measurement Locations at Sheerline: (Steel Rulers were taped to the side of the hull with the 0mm mark on sheerline)

All tests were done with boat floating in **Salt Water** according to procedure outlined in Section L of the 2.4mR Class Rules. This was done in local waters next to our dock. Salinity of water was not checked at this time, but tables indicate it should be considered average (1.025 kg/L) I did not have access to a freshwater tank for testing purposes. An average of 4 photos were taken at each section ruler to come to an average freeboard. Even in relatively calm water, wave action around the hull could vary the freeboard measurement number at any given time.

Note: In tests 3,4 the 35kg weight was moved 150mm further aft as this boat exhibits a stern high position when filled with water. (extra foam in stern ???)

Keith Gordon noted 2.4 NOD boat construction is required to middle of tolerances to ensure template compliance.

Keith Gordon noted ballast is 170kg not 181kg + correctors – liquid foam buoyancy used in lieu of rigid closed cell foam buoyancy which we understand may add up to 12kg to the boat weight? CNC cut rigid closed cell foam to be used for future 2.4 NOD boats.

Keith Gordon noted boat floated bow down with ballast forward – 2.4mR CR C.5.2 (b) requires boat to float in an approximately horizontal position.

Waterline declaration by official measurer to 2.4mR CR D.6.1 (c) is World Sailing requirement.

Rikard Bjurstrom has issued 5 2.4 NOD stickers to Super 3.

Bruce Millar advised that the 2.4 NOD chainplate deflection test requirement was introduced to address boat flexibility issue (not chainplate screw fixing failure).

Bruce Millar discussed 2.4 NOD boat construction with Brian Harding to ensure that the 2.4 NOD class rules and construction manual facilitate good quality 2.4 NOD boat builds:

- ❖ Do we need to amend the laminate specification to less than 3.6kg/m²?
- ❖ Keep laminate as specified, consider deck laminate design option, Brian Harding to review with laminate designer.
- ❖ Do we need to increase the tolerances on templates?
- ❖ Templates OK except stern template to be shortened to fit centreline.
- ❖ Will a weight control plan assist with achieving 181kg ballast + correctors?
- ❖ Brian Harding confident next 2.4 NOD boat will be on 181kg ballast. Liquid foam to be replaced with rigid closed cell foam on future 2.4 NOD boats. Builders' plaque discussed, Rikard Bjurström confirmed EU rules do not require plaque for racing equipment, EU rules require model and serial number for recreational equipment only - 2.4 NOD plaque requirement defined in class rule D.2.6 (c) Identification.

Number of Equipment Inspection days not adequate for up to 120 boats – allow 2 days for equipment inspection with final morning for compliance wrap-up. Schedule to be amended and race numbers to be corrected for 11 races. Equipment Inspection to be in accordance with 2.4mR World Championship Inspection Plan. Event insurance to be reviewed E2 million is policy limit in many 2.4mR countries. World Sailing is the Organizing Authority for the 2.4mR Para World sailing Championship – delegation to be agreed with World Sailing. Thomas Jatsch noted that Keith Gordon has been appointed as 2024 2.4mR World Championship IM. Peter Russell to forward the 2.4mR World Championship Inspection

Plan and associated documents to Thomas Jatsch for a meeting with the Organizing Authority. Peter Russell to prepare TC review for issue to EC meeting 06.02.2024.

28.02.2024 TC comments on NOR forwarded to Organizing Authority by EC. TC can prepare Equipment Inspection NOR clause if required.

03.04.2024 Organizing Authority has received TC comments on NOR – no revised NOR issued to date. Keith Gordon noted WS (Hannah Stodel) has commented on Parasailing World Championship requirements – WS comments to be addressed by EC - TC has not received any advice from WS regarding NOR for review. TC response issued to EC on 12 July 2024 noting SIs not complete and inconsistent with draft NOR. Racing in split gold and silver fleets not ICA preferred fleet racing due to shipping lane restrictions. TC noted strong preference for fleet racing, we travel to World Championships to sail together with equal opportunity to race against all competitors. TC also noted significant event logistics requirements for split fleet racing.

TC thanked Thomas Jatsch for helpful event inspection training and work with a smile.

Current 2.4mR World and Continental Championship Management documentation approved. 2.4 NOD 181kg ballast weight checks discussed – no requirement to add to Inspection Plan – check subject to World Sailing requirement. Peter Russell noted concern about the time and effort required to check that the 2.4 NOD ballast weight is 181kg. Removing ballast/weighing ballast/installing ballast takes an average of 25 minutes per boat and requires a minimum of two people. Boats that have not had ballast removed recently may require boats to be inverted to remove lead where lead is stuck, or

inserts rusted and requires a separate equipment inspection team. 2.4 NOD owners and their support team may not be able to remove ballast themselves – if ballast removal is required it becomes an Organizing Authority task. The recommendation is to accept a 2.4 NOD certificate and total weight check of 253-254kg as evidence of compliance with the 181kg ballast rule.

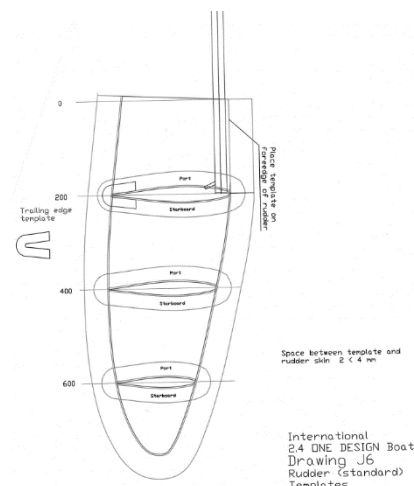

Stellan Berlin noted alternative courses to ensure competitive racing should be considered. Peter Russell to amend update to allow for alternative course configurations.

I Rudderstock

31.01.2024 Parts of rudder discussed – rudderstock (one word) agreed as correct term – word rudderstock and materials to be regularized. 2.4mR Class Rule D3.1 permits rudder stock to be “of any materials” E.4.2 prescribes rudderstock of stainless steel or aluminum. 2.4 NOD Class Rules E.2.6 & E.2.8 rudder stock.

28.02.2024 Parts of rudder discussed – rudder terms are rudder blade, rudderstock, rudder port tube, rudder armature, rudder steering lines. 2.4 NOD class rules to be amended with “rudderstock” one word and D.7.1(a) (3) “rudder post” deleted as not a fitting. 2.4mR Class Rule D3.1 permits rudder stock to be “of any materials” E.4.2 prescribes rudderstock of stainless steel or aluminum.



J Mainsail Edge Measurement

31.01.2024 Mainsail edge measurement discussed. There is no ERS or 2.4mR Class Rules for straight sail edges from top batten to aft head point. Sails with a local curvature to be measured with batten to ERS ensuring sail extension does not affect head width. North sails noted as straight and Neb sails noted as minor curvature between upper leech point and aft head point.

28.02.2024. Peter Russell advised Doyle sailmaker that local curvature from upper leech point to aft head point is required to comply with ERS H.5.4 Extended as necessary as follows:

H.5.4 Extended as necessary

If there is local curvature and/or irregularity in the **sail edge** leading into a corner point, the extension of the **sail edge** shall be found as follows using a batten as specified in H.5.4(e) :-

- Hold the batten at its very ends with one end approximately where the **corner point** will be and the other end touching the **sail edge** being extended.
- Apply compression only to the batten to produce a uniform curve when required.
- If the batten does not replicate the sail edge shape exactly, move the end of the batten at the **corner** away from **sail** until the longest possible length of the batten touches the **sail edge**.
- Where this technique does not provide a repeatable **corner point**, ERS H.1.2 shall apply.
- Battens shall be of a specification approved by World Sailing unless otherwise specified in class rules.

K World Sailing Hannah Stodel Meeting

28.02.2024 Meeting with World Sailing on 12.02.2024 confirmed parasailing “inclusive” strategy. Bruce Millar preparing response on 2.4 NOD class rules. *NOTE The 2.4 NOD Class Rule controls all factors affecting boat speed but allows internal structure and rigging options to ensure that the boat is a truly inclusive class able to be sailed by people of all abilities.*

L 2.4mR Lifting Eye

28.02.2024 Peter Russell advised the EC on 16.02.2024 of a Rondar 2.4mR boat lifting eye failure. The failure occurred over water, and fortunately no-one was injured. The front lifting eye failed first so the

rig was OK. Subsequent inspection has found that one other Rondar boat has lifting eye lamination failure. The lifting eye failure is a Rondar 2.4mR boat issue.

Lifting eyes are not required under the 2.4mR class rules. Lifting eye design is the responsibility of the builder. Keith Gordon noted that Weymouth Olympic Centre requires all boats to be lifted with their certified lifting slings. Keith Gordon noted that short lifting strops impose a sheer force on lifting eyes. Requirement for adding a lifting eye requirement to 2.4mR class rules discussed – agreed that the design of the method of lifting 2.4mR boats is the builder's responsibility and that a class rule change to add lifting eyes is not consistent with the open rule. Requirement for periodic testing of 2.4 NOD lifting eye load capacity discussed – agreed that 5 yearly checks are not required however advise that all 2.4 NOD owners regularly check lifting eyes and lifting strops for potential failure as for all boat rigging. Lifting eye load capacity can be checked over water with boat not rigged to address safety protocols. EC to consider Rondar 2.4mR boat safety warning options.

03.04.2024 Bruce Millar advised that the EC has communicated with Super 3 regarding Rondar 2.4mR boat lifting eye safety advice to owners. Thomas Jatsch advised Rondar 2.4mR boat built 2021 single lifting eye successfully tested to 345kg load – Thomas to photograph next lifting eye test for information.

M 2.4mR Forestay Rigging Point

03.04.2024 Draft forestay rigging point interpretation request agreed by TC - Peter Russell to submit to World Sailing for interpretation.

27.05.2024 2.4mR Rigging Point Interpretation effective 21 May 2024 issued by World Sailing posted on 2.4mR website. Where a saddle changes the way the rigging is attached to a mast the rigging point is determined by the 'IN OTHER WAYS' definition.

N 2.4mR Canada Ballast Motion Canadian 2.4mR AGM - April 11, 2024

24.04.2024 Motion:

I propose that in ALL Norlin Mk3 boats to carry up to a maximum keel ballast (lead) weight of 181kg in ALL regattas sailed in Canada.

Reasoning:

By restricting lead weight boats, it will be limited in their righting ability ("righting moment") therefore equalizing a major component of boat speed especially in heavy air. This in turn makes the sailors skill the primary reason for performance. For the past 15 years or so there has been a One Design component for Norlin Mk3 (NOD)boats in North America. Within the current NOD rules the maximum lead is set at 181kg. All boats received in the past 15years have been produced within this specification. The 2.4mR rule does not set a maximum lead. In theory you can take a boat and strip out the interior to add lead in the keel. There have been only a few examples of this in North America with 98% of the boats 181kg.

A boat with more than 181kg lead in the keel can easily be changed by taking the weight from the keel and attaching it as a corrector weight in the cockpit. This proposal would still allow any other 2.4mR design and any Norlin Mk3 boats that have not been measured to NOD to compete together in all regattas. This proposal has been suggested to the USA class as well for consistency across North America.

Suggested Implementation Date: September 1, 2024

During the Canadian 2.4mR AGM the motion was proposed discussed, and questions answered. A vote was held, and the result was unanimous in favour of the proposal. I am hereby requesting that the TC approve a recommendation of the 2.4mR class rules under section 87 of the RRS to be used in Canadian regatta's after September 1, 2024.

Bruce Millar, On behalf of the Canadian 2.4mR Class Association

TC discussed proposal that for 2.4mR racing in Canada the maximum ballast for 2.4mR Norlin Mk 3 boats is 181kg and commented as follows:

- ❖ The 2.4mR Norlin Mk 3 is a boat design but not a boat class.
- ❖ 2.4mR events preferably are inclusive of all 2.4mR rated boat designs.
- ❖ Certification of 181kg ballast weight questioned – no measurement noted.

- ❖ 2.4mR boat designs are noted as optimised up to approx. 190kg ballast.
- ❖ Re-certification of 2.4mR boats will be required with ballast changes.
- ❖ Competitor agreement to limit ballast to 181kg could be subject to competitor protest.
- ❖ Approved class rules changes are required in event NORs.

O Certification Advice

20.06.2024 Certification Advice draft reviewed. 2.4mR certificate notes to include alternative MNA examples - SWE, GBR and FIN to provide certificate examples for reference. Sailor classification noted as additional organising authority requirement. 2.4 NOD certificate diagram to be amended to delete reference to Henrik.

P 2.4mR World Championships

20.06.2024 Bruce Millar advised 2025 World Championship to be Italy Lake Garda, May or October dates to be confirmed. 2026 World Championship Norway or Netherlands.

21.08.2024 Bruce Millar advised 2025 World Championship to be Italy Lake Garda from 7-12 October 2025. 2026 World Championship Norway or Netherlands.

23.10.2024 Bruce Millar advised 2025 World Championship to be Italy Lake Garda from 7-12 October 2025. TC to assist with race documentation.

20.11.2024 TC agreed to prepare NOR template based on 2025-28 RRS to assist 2025 Italy World Championship Organising Authority with NOR preparation. Heiko Kroger to advise if WC is approved as Inclusive WC by World Sailing and advise any WS NOR requirements. Peter Russell to prepare draft for TC review.

Q Mainsail Limit Marks

21.08.2024 Mast upper limit mark CR C.9.2. (a) (2) compliance – check on water with video/photo evidence of non-compliance not practicable. TC to consider compliance options – stopper not possible with halyard lock fittings, halyard lock is equal to stopper installation. Luff tape installation varies - highest point of mainsail may not be at mast track. Consider use of “suitable fitting or system” wording as per CR D.7.1 (a) (1). Refer 470 clarification advice. A competitor may protest another boat for non-compliance with the class rules.

21.08.2024 Boom outer limit mark CR C.9.2. (a) (2) compliance – check on water with video/photo evidence of non-compliance not practicable. TC to consider compliance options - stopper not possible as track optional, consider adding foot dimension max. 1960mm? A competitor may protest another boat for non-compliance with the class rules.

23.10.2024 Mast upper limit mark CR C.9.2. (a) (2) compliance – check on water with video/photo evidence of non-compliance not practicable. Compliance options considered by TC – stopper not possible with halyard lock fittings, halyard lock is equal to stopper installation. Luff tape and bolt rope fixing varies - highest point of mainsail may not be at mast track. TC noted limit mark measurable, no evidence of non-compliance, agreed to retain existing class rule. A competitor may protest another boat for non-compliance with the class rules.

23.10.2024 Boom outer limit mark CR C.9.2. (a) (2) compliance – check on water with video/photo evidence of non-compliance not practicable. Compliance options considered by TC - stopper not possible as track optional. TC noted limit mark measurable, no evidence of non-compliance, addition of 1960mm maximum foot dimension class rule not practicable. A competitor may protest another boat for non-compliance with the class rules.

R 2.4 NOD Sail Identification

21.08.2024 2.4 NOD boat national letters and sail number CR CG.3.1 (c) compliance – some national letters and sail numbers noted as exceeding maximum dimensions. TC agreed to delete maximum dimensions as administrative change so rule equivalent to 2.4mR class rules.

21.08.2024 Sail number contrast – Thomas Jatsch noted white letters on black sails difficult to identify subject to sun orientation. Peter Russell noted that ICA preferred course diagram requires boats to finish astern of the start boat on a reach (not on a run as per 2024 WC SIs) to facilitate boat identification. An upwind finish can also facilitate boat identification.

23.10.2024 2.4 NOD boat national letters and sail number CR CG.3.1 (c) compliance – some national letters and sail numbers noted as exceeding maximum dimensions. 2.4 NOD national letters and sail number maximum dimension deleted from class rule. CRC held pending outcome of buoyancy check.

20.11.2024 2.4 NOD boat national letters and sail number CR CG.3.1 (c) compliance – some national letters and sail numbers noted as exceeding maximum dimensions. 2.4 NOD national letters and sail number maximum dimension deleted from class rule. CRC held pending outcome of buoyancy check.

S Safety Advice

21.08.2024 Safety advice – Thomas Jatsch noted 2024 2.4mR World Championship Germany race support boat crew training in rescuing swamped 2.4mR boat useful. 2.4mR Advice note to be prepared, Thomas Jatsch to forward training photos to Peter Russell for advice preparation.

23.10.2024 safety advice – draft 2.4mR Safety Advice note prepared, Thomas Jatsch to forward training photos and notes to Peter Russell for advice completion. Keith Gordon to confirm recommended pump size. Key issues:

- ❖ Save the person first – safety not competing is the priority.
- ❖ Race support boats to be on water for pre-start, race and post-race to support all competitors.
- ❖ Race support boat pump-out facility for swamped boats enables race support boats to remain on-course, towing to event centre not required.

20.11.2024 safety advice – draft 2.4mR Safety Advice note prepared, Thomas Jatsch to forward training photos and notes to Peter Russell for advice completion.

20.11.2024 Recommended race support boat pump specification confirmed as 12 volt 3700 GPH bilge pump (233litres/minute) with 38mm hose size.

21.08.2024 TC reviewed new 2025-2028 ERS changes to verify class rule compliance with new ERS. ERS changes do not affect 2.4mR or 2.4 NOD class rules.

- ❖ B1.3 Boom outer point definition = foreside of boom outer limit mark
- ❖ G.5.5 Upper leach point definition = distance from head point (not peak point)

U Buoyancy check additional weight

21.08.2024 Class rule change «lead» to «test weight» agreed as administrative change only. 2.4 NOD Class Rules to be amended, CRC submission for WS approval to be prepared.

23.10.2024 Class rule change «lead» to «test weight» agreed as administrative change only. 2.4 NOD Class Rules amended – issue held pending TC resolution of «test weight». CRC submission for WS approval prepared by Peter Russell. World Sailing advised CRC to be considered as separate application to pending CRC review.

23.10.2024 Definition of «test weight» discussed. 35kg noted as designed to simulate the weight of a submerged person. Density definition required to control test weight – comparative weights in g/cm³, lead = 11.20, steel = 7.85, iron = 7.87, aluminium = 2.70, concrete = 2.4, salt water = 1.025. TC agreed test weight density to be a minimum of 5g/cm³ assuming ferrous metal with plastic or other coating.

23.10.2024 TC discussion continued – do we need the «test weight» - can the buoyancy check be conducted with the boat flooded with water only? Bruce Millar to conduct buoyancy check with «test weight» and water only and advise difference if any in floatation position. CRC held pending outcome of buoyancy check.

U Boat Register

20.11.2024 Thomas Jatsch requested consideration of establishing a boat register to assist with records management. Bruce Millar has forwarded existing boat register to Thomas for information. TC noted data protection requirements. Rikard Bjurström noted that requirement for sailors to lodge boat certificates as part of registration process for 2023 Finland WC resulted in no boat certificate issues. TC noted that some sailors lack understanding of certificate forms – refer TC certificate advice. Thomas noted that he now has a database of over 300 boats. NCAs to consider database options.
